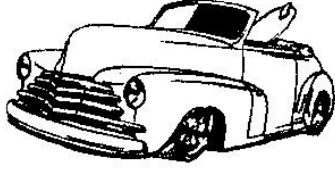
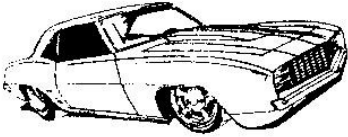

All vehicles must be street legal with current state tags, licensed and insured (no motorcycles or scooters). No excessively loud exhaust systems. This event is limited to 3,000 vehicles and sells out. The Entry Fee includes Driver, 1 Adult Passenger and Children under 14. Additional event passenger/guest passes may be purchased for \$20 each in advance. (The entry fee minus processing fee is refundable with written request prior to March 1, 2009.)
